The Local Spiritual Assembly of Baguio City had a meeting on January 20, 2019 with the requested attendance of ABM Celma Lucero to listen to Joan Andrea S. Toledo's statement about a case of alleged sexual abuse by her father Mr. Antonio Lim Toledo.

Attached herewith is the Initial Medico-Legal Report with reference SA18-123SPD/S conducted by the Southern Police District Crime Laboratory Office in Brgy San Antonio Makati City, requested by the Muntinlupa City Police Station – WCPD, and was examined by Reah M Cornelio, MD, Police Chief Inspector, Medico-Legal Officer of the Southern Police District Crime Laboratory Office with a conclusion; **“Medico-legal evaluation shows clear evidence of blunt penetrating trauma to the hymen.”**

The examination report was completed on June 26, 2018 at 9:15 AM.

This Medico-Legal Report is presented to the Local Assembly as evidence of the Alleged Sexual Abuse perpetrated by Mr. Antonio Lim Toledo.

Our beloved friend, Joan Andrea S. Toledo, is humbly pleading for justice to be served.

Her plea was submitted to the Universal House of Justice and to the National Spiritual Assembly through a letter dated December 25, 2018.

Quote: **“Motion to file the Loss of Right to Parenthood and to permanently remove the Baha'i Administrative rights of ANTONIO LIM TOLEDO on the Grounds of Incest Rape.”**

The Local Assembly also has noted the advice of the Universal house of Justice.



Quote: **“With respect to how to move forward in light of your situation, such matters are best addressed by Baha'i institutions in the area concerned, and you are lovingly encouraged to turn to your National Spiritual Assembly, to whom you have also sent a copy of your letter, as it is in the best position to become acquainted with the particulars of your circumstances and to offer you appropriate guidance and support.”**

We may refer to the letter of the Universal house of Justice to bahai.lady.19@gmail.com on August 8, 2014 copied to The National Spiritual Assembly of the Baha'is of the Philippines about this quote. In the meeting with our beloved Joan Andrea S. Toledo, it was expressed to her the hope that she continue turning to the remembrance of God and be patient with the Assembly as the case is followed up. As a haven for the distressed and an upholder and defender of the victim of an alleged oppression, the Local Assembly therefore would like to follow up on this matter, seek advice and offer help for the speedy investigation and resolution to this case.
